1. Welcome and apologies

The Chair welcomed everyone to the meeting. Apologies for non attendance were noted. The Chair noted that attendance constituted a quorum.

2. Update on Panel membership

The Secretary provided the following updates –

 CH noted he had had further exchanges with the CBI regarding a nomination for a member to the Panel to represent large usage demand customers; and • CH noted that NIRIG had nominated Gemma Monaghan from Air Core NI to replace Mervyn Adams on the Panel as a representative for small generators.

3. Review of minutes of previous meeting, including actions

CH advised the Panel that a revised draft document would be ready soon for circulation to the Panel for review.

JOB advised that the Utility Regulator (UR) had some thoughts on how retrospective application of D Code amendments should be worded in the document. JOB said he would send through some suggested wording for insertion into the document.

RS raised a question about the process for amending Setting Schedules stating that as these were joint documents with SONI, SONI would need to be involved in any amendment process.

CH advised that the proposed arrangements for amending the D Code would apply equally to the Setting Schedules, and thus SONI would have ample opportunity to feed in to any proposed amendments to same.
